Applicants Agreement: Inconsideration of your accepting my entry, I the undersigned, on behalf of the boat, boat owner and all of my crew member, acknowledge and agree to to bound by "the racing rules of sailing" and by all other rules that govern this Regatta. I hereby attest that my boat will have all the required equipment aboard, that she will be seaworthy in hull, rig and gear, that she meets the WFPHRF Category One safety, equipment and crew requirements and that she will be responsibly manned. I hereby agree that the West Florida PHRF rating certificate that is filed with this entry is a true copy of my valid rating certificate and that no changes have been made to my vessel that would change her rating. I and my crew also consent to the use of any photographs either of persons or boats, either on the water or land, for any purpose by future Bone Island Regatta, its sponsors, co-hosts or affiliates. I understand that competitors compete in this regatta entirely at their own risk. See Rule 4, Decision to Race. The organizing authority, host clubs, sponsors, their associates, appointees, or any families of these will not accept any liability for material damage or personal injury or death sustained as a result of this Regatta, whether it is before, during or after the Regatta.

Release of Liability: In consideration of the undersigned, Owner, Skipper or Charterer and his crew's participation in the Bone Island Regatta (the "Regatta") hosted by local sailing clubs and/or Yacht Clubs, (hereinafter to be know collectively as the "Hosts"), the undersigned participant (the "Participant") on behalf of him/herself and their crew, their respective heirs, executors, administrators, personal representatives and next of kin (hereinafter referred to, collectively with the participant as "Releasers"), hereby waives, releases, and discharges each of the Sponsors, Hosts and any related or employed individual from any and all claims, demands, damages, judgments executions, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, which a Releaser may have or claim to have, against any Released Party resulting from death, personal injury, property damage or other loss Releaser may sustain as a result of participating in this Regatta or any related activity thereto.

This Release is intended to discharge each released party from any and all liability arising out of or connected in any way with releaser's participation in the regatta even if that liability arises out of negligence or carelessness on the part of any released party. Releasers hereby acknowledge that serious accidents occasionally occur during sailing activities and that fatal or serious personal injuries and/or property damage or other loss may result from participation in the Regatta. Releasers knowingly assume all risks of participation in the Regatta, including all risk of personal injury and loss or damage to the Releasers or their property, including further injury sustained as a result of the efforts of third parties who come to the aid of Releasers if injured as a result of participation in the Regatta, and release all other persons and entities mentioned above who might otherwise be liable to Releasers. Releasers agree to follow all rules of the Sponsors/Hosts in connection with their participation in the Regatta and understand that the failure to observe and obey such rules may result in the instant disqualification and/or right to participate in the Regatta.
